Washington on Wheels (WOW) mobile health clinic is temporarily in Santa Rosa, California, helping support our North. Bay neighbors who were devastated by October's wild fires. Santa Rosa Community Health serves 50,000 patients annually. The wild fires caused extensive fire, smoke and water damage to its largest clinic, Vista Campus, and resulted in the loss of 56 patient exam rooms. therapist, cardiac rehab exercise therapist, and currently works with outpatients in the pulmonary rehab program.

Nancy Farber introduced Nicholas Legge, Assistant Chief, System Operations and Management Support Services who presented an update on Value Stream and Kaizen Workshops conducted in Perioperative Services – Elective Neuro Surgery. He reviewed the Value Stream Mapping done in May 2017 which was a critical exercise to designing the future state of elective neurosurgery. The first workshop was a 5S held in July 2017 which focused on the Equipment Room, Core Supply and Anesthesia Room. The second workshop focused on pre-op testing with a focus on improving the patient experience while reducing last minute cancelations.

The third workshop, held in November 2017, focused on surgery scheduling standard form for physicians, clinic standard work for surgery scheduling, OR scheduling standard work, and Epic technology improvements. The fourth workshop, held in January 2018, concentrated on the physician/case preference cards which are critical for accurate scheduling, set up, patient positioning, and supply for cases. The fifth workshop was held March 2018 and focused on room turnover and set up.

Ed Fayen presented the construction update on the Morris Hyman Critical Care Pavilion sharing photographs of the first floor X-Ray room floor prep; installation of Terazzo flooring on the first floor; second floor north west CCU; second floor atrium flooring; second floor staff lounge; WON door installation second and third floors; steel structure erected for south side entry canopy for new ED; most covers concrete placement; forming and rebar for stairs at north east entry; north side paving and base demolition; base rock placed for concrete slab at new loading dock; concrete roof deck placement for new loading dock; and ending with the Site View.

Mary Bowron, Senior Director of Quality and Resource Management presented the American College of Surgeons National Surgical Quality Improvement Program 2018 Update. Washington Hospital received "Exemplary Status" for ranking in the top 10% of hospitals with lowest mortality rate having a statistically significantly lower observed rate of mortality than what was expected and for ranking in the top 10% of hospitals with lowest complications having a statistically significantly lower observed rate of 30-day morbidity (complications) than what was expected. Washington Hospital had a lower rate of unplanned, 30-day all cause surgical readmissions than expected and a lower rate of unplanned returns to the Operating Room within 30 days of surgery compared to the expected rate as well as a lower rate of respiratory complications compared to the expected rate.

Washington Hospital received "Exemplary Status" for ranking in the top 10% of hospitals with lowest surgical site infections having a significantly lower rate of surgical site infections and a lower rate of urinary tract infections, sepsis, and C.diff infections compared to the expected rate; for ranking in the top 10% of hospitals with lowest mortality in general surgery having a statistically significantly lower mortality and lower complications, infections, renal failure and readmissions than what was expected; and for ranking in the top 10% of hospitals with lowest

morbidity, renal failure and urinary tract infections in cardiac surgery having a statistically significantly lower morbidity, renal failure and urinary tract infection rate, and lower surgical site infections, readmissions and ventilator duration over 48 hours rate than what was expected.

Washington Hospital received "Exemplary Status" for ranking in the top 10% of hospitals with lowest rates of readmissions and urinary tract infections in orthopedic surgery for knee replacement having a statistically significantly lower readmission and urinary tract infection rates and lower complications, surgical site infections, and blood clots in the 30 days post-surgery compared to what was expected and for ranking in the top 10% of hospitals with lowest rates of complications among hip replacement patients having a statistically significantly less complications and lower rates of blood clots, infections and readmissions in the 30 days post-surgery compared to what was expected.

Chris Henry, Chief Financial Officer, presented the Finance Report for January 2018. The average daily census was 185.6 with admissions of 1,204 resulting in 5,753 patient days. Outpatient observation equivalent days were 128. The average length of stay was 4.90 days. The case mix index was 1.424. Deliveries were 134. Surgical cases were 381. Joint Replacement cases were 163. Neurosurgical cases were 21. Cardiac Surgical cases were 7. The Outpatient visits were 7,292 and Emergency visits were 4,954. Total productive FTEs were 1,294.7. FTEs per adjusted occupied bed were 6.05.

FINANCE REPORT

Nancy Farber presented the Hospital Operations Report for February 2018. Preliminary information indicated gross revenue for the month of February at approximately \$159,440,000. The Average Length of Stay of 4.64 and there were 4,767 patient days. There were 365 Surgical Cases and 287 Cath Lab procedures at the Hospital. Deliveries for February were 143. Non-Emergency Outpatient visits were 6,902. FTEs per Adjusted Occupied Bed were 6.38. The Washington Outpatient Surgery Center had 413 cases and the clinics saw approximately 3,286 patients.





Comparison of February acute inpatient statistics to those of the budget showed a lower level of admissions and a lower level of patient days. The average length of stay (ALOS) based on discharged days was below budget. Outpatient visits were higher than budget. Emergency Room visits were below budget for the month.

2. Staffing – Schedule Board 3

Total paid FTEs were 119.0 below budget. Total productive FTEs for February were 1,262.3, 122.8 below the budgeted level of 1,385.1. Nonproductive FTEs were 3.8 above budget. Productive FTEs per adjusted occupied bed were 5.57, 0.11 below the budgeted level of 5.68. Total FTEs per adjusted occupied bed were 6.39, 0.04 below the budgeted level of 6.43.

3. Income - Schedule Board 1

For the month of February the Hospital realized income of \$2,172,000 from operations.

Total Gross Patient Service Revenue of \$159,440,000 for February was 7.7% below budget.

Deductions from Revenue of \$119,527,000 represented 74.97% of Total Gross Patient Service Revenue. This percentage is below the budgeted amount of 77.09%, due to favorable payor mix and the reduction of previously recorded RAC reserves.

Total Operating Revenue of \$40,379,000 was \$269,000 (0.7%) above the budget.

Total Operating Expense of \$38,207,000 was \$2,134,000 (5.3%) below the budgeted amount.

The Total Non-Operating Income of \$1,193,000 for the month includes an unrealized loss on investments of \$446,000 and property tax revenue of \$1,356,000.

The Total Net Income for February was \$3,365,000, which was \$1,865,000 more than the budgeted income of \$1,500,000.

The Total Net Income for February using FASB accounting principles, in which the unrealized loss on investments and property tax revenues are removed from the non-operating income and expense, was \$2,455,000 compared to budgeted income of \$145,000.

4. Balance Sheet – Schedule Board 2

Bond Debt Service Funds and Accrued Interest Payable decreased due to the February 1 semi-annual interest payments on the General Obligation Bonds.

There were no other noteworthy changes in assets and liabilities when compared to January 2017.
