PCCI "Pieces" Capital Request

We have been working with PCCI for several months on an agreement to install PCCI's "Pieces" electronic coordination and clinical decision support system.

Pieces looks at our Epic data in real time to:

- Identify patients with specific illness;
- Employ electronic predictive models to assist providers in anticipating adverse clinical events;
- Assist physicians, nurses and administrators in complex decision making related to these patients;
- Coordinate and monitor clinical and operational action plans at the individual and patient population levels.

The result will be better post-acute care plans and the avoidance of readmissions as a result of early detection of patients who may be at risk.

We will be the first hospital on the West Coast to have access to this system. We have been approved by the Moore Foundation for a \$100,000 Charter Customer grant to help with the first year costs.

We are proposing the installation of:

- Pieces All Cause Base Platform
- Impression Case Management Portal Service
- Pieces CHF Disease ID Service Pieces AMI/PNA Disease ID Bundle Service
- Management Dashboard Service

Capital cost of the system is \$205,608. This was not included in the FY 2015 capital budget; however we are proposing trading out funding for McKesson system upgrades that were budgeted for FY2015.

Should the Board approve this request, the team from PCCI is prepared to begin the project in mid-January, with an estimated completion date in early June.
